ratification of the Constitution of the United States
of America, by the state of Virginia, and to re-
sume all the rights and powers granted under
said Constitution", adopted in Convention at the
city of Richmond, on the 17th day of April,
1861 — and the following is a statement of the
vote as exhibited by the poll books: For Ratifi-
cation 130 votes; For Rejection 1 vote
